presents its compliments to the Permanent Mission of ... to the United Nations and has the honour to recall its communication No. DOALOS/03-00081 dated 18 February 2003.

In this communication, the Division drew the attention of the Permanent Mission to General Assembly resolution 57/141 of 12 December 2002, in which the Assembly, inter alia, had encouraged States parties to the United Nations Convention on the Law of the Sea of 10 December 1982 that are in a position to do so to make every effort to make submissions to the Commission on the Limits of the Continental Shelf regarding the establishment of the outer limits of the continental shelf beyond 200 nautical miles within the time period established by the Convention, taking into account the decision of the eleventh Meeting of States Parties to the Convention (SPLOS/72).

The Division also drew the attention of the Permanent Mission to the Capacity-Building section of resolution 57/141, and requested Governments to provide, as soon as possible, a list of the sources of training, advice and expertise and technological services, including relevant institutions and other sources of technical
