

Chart \$ - Re!ular %ud!et Collection Trend

Monthly collections fluctuate a lot, large amounts are still uncertain and received at the end of the year.






Chart 2 - Re!ular %ud!et Cash %alance Trend (US\$ millions)










Chart 3 - Re!ular %ud!et Cash "osition















Chart \$* E > utstandin! contri&utions at #eace 'ee#in!; iscal year end




Chart \$. - > utstandin! "ayments to Mem&er States
